I am pleased to supply the information you requested, as follows:

The PCT's Strategic Plan 'Living Well, Living Longer – One Year On' is also available on the website under the Publications tab, and should provide much of the information you have requested.

The PCT has been through a prioritisation process as part of the financial planning for 2010/11. This has resulted in some disinvestment from schemes which were not providing a sufficient benefit for the investment. We have done this in order to protect investment in our priority areas which include lifestyle interventions and support for people with long term conditions.

We are not yet in a position where we have finalised our plan for 2010/11 and obviously it will have to remain under constant review. We are, however, committed to transparency around this and will discuss plans with OSC, LINKs and at our public board meetings. Where consultation is necessary, this will take place.


